Meeting Notes (red text highlights action items)

1. Accreditation and Registration Update

- Jackie Krizmanic, AEMO's Accreditation and Registration Lead, presented a summary of the changes made to the second draft of the POC Industry Accreditation and Registration Plan.
- AEMO indicated that a third draft will be sent which contains updated information on the registration process for Metering Coordinators.
- Questions and comments made by the POC-RWG at the meeting included:
 - What impact does the Victorian Government's decision have on the processes for accreditation and registration? AEMO indicated that the exact details of this will not be known until the Victorian Government's releases its Order in Council in mid-May. However, AEMO is assuming that no changes will be required to Qualification Procedure or the POC Industry Accreditation and Registration Plan. AEMO is also assuming no changes are required to MC Registration Guide and MC Application Forms.

2. Transition and Cutover Update

- Paul LeFavi, AEMO's Industry Transition and Cutover Lead, presented a proposed approach for industry transition and cutover planning.
- AEMO posed a question to the RWG about whether a smaller focus group should be established to assist in transition and cutover planning.
- There were mixed views on this from the RWG. Some participants supported the establishment a smaller focus to work through specific deliverables. These details would then being reviewed by the RWG. However, some participants did not agree with the need for a smaller focus group and wanted to be party to all transition and cutover planning discussions.
- Participants were invited to send their views on the establishment of a focus group or any
 information regarding industry transition and cutover planning to AEMO by 11 April 2017.
- AEMO indicated it would send the RWG a list of draft guiding principles to assist with industry transition and cutover planning.
