WEMS-6067	The error message associated with settlement report requests for data prior to 1 July 2012 insufficiently describes the cause of the issue.	Requests for settlement data prior to 1 July 2012 will return an error message depending on the request type. An sample error message is: <i>'Data prior to Trade Date 1 July 2012 is not currently available in the settlements portal. Please contact IMO Market Operations at operations@imowa.com.au to request this data.'</i> When requested through web service, an error code 400 will be returned.	Low
WEMS-6057	Users are unable to identify the adjustment number for PIR and Statements in the MPI. Users accessing through web services are able to see the adjustment number.	The adjustment number applicable for a PIR or Statement can now be identified in the settlement portal via the MPI.	Low
WEMS-6075	The 'by Trade Date' tab in the Reports section of the MPI omits certain reports that are available from the 'by Report' tab.	All reports are now visible in the 'by Trade Date' and 'by Report' tabs within the MPI. Please note that a report can only be downloaded after it has been published by the IMO. The 'by Report Type' tab has been removed.	Low
WEMS-6080	Approval of NDL association change requests incorrectly interpreted end dates causing contract overlap errors.	The change request workflow for NDL associations now correctly handles submitted contract end dates.	Low
