## 1. Background

#### 1.1 Matter under consultation

AEMO has received a letter from the Tasmanian Government in accordance with clause 7.1.4 of the *Rules* requesting amendment to the *metrology procedures*. This letter is published on the *AEMO* website with this report.

The objectives of this consultation are to:

- To vary the *metrology procedures* to facilitate the introduction of Full Retail Contestability (FRC) in Tasmania, as provided by the Tasmanian Government; and
- Ensure that Consulted Persons are properly informed about the proposed and final outcome.
