1 Welcome and previous meeting minutes

Dean Sharafi (AEMO) opened the meeting at 10:02pm, welcomed attendees to WAECF No. 42.

The minutes from the previous WAECF (22 February 2023) were endorsed. AEMO to publish the minutes as final on the website (action item 1.1).

2 AEMO Operational Updates

2.1 Power System Update

David Weinholz (AEMO) presented a power system update focusing on the tools and processes AEMO uses for operational forecasting and specifically the planning and actuals for the recent solar eclipse.



2.2 Reserve Capacity (RC) Update

Neetika Kapani (AEMO) provided an update on Reserve Capacity activities, announcements and key milestones associated with the 2022 reserve capacity cycle and upcoming dates for the 2023 RC Cycle - deferred timetable. Neetika also noted the WEM Electricity Statement of Opportunities (ESOO) is on track for publication on 10 July 2023 and based on early indications from the 2023 WEM ESOO draft demand forecasts, AEMO expects that a process to procure Supplementary Reserve Capacity (SRC) will be triggered for the 2023-24 capacity year.

2.3 Supplementary Reserve Capacity (SRC) Update

Manus Higgins (AEMO) provided an overview of SRC, the procurement process and stepped through some of the SRC activities from the 2022-2023 summer period.

Stakeholder questions and feedback

Matthew Bowen (Jackson McDonald): Can you share more details of the VPP responses? How many MW. And who the VPP provider was?

AEMO: There was between 800-900 residences in the Dunsborough region, that provided approximately 2 MW.

Noel Schubert: How many MW was offered?

AEMO: 100 MW was offered

2.4 Quarterly Energy Dynamic (QED) Report Insights

Adrian Pearce (AEMO) presented some key insights from the Quarter 1, 2023 QED that was published on 28 April 2023 noting:

- Cooler temperatures than Q1 2022 flowed through to reduced operational demand
- Coal preservation program ended mid-way through the quarter, impacting the fuel mix
- Balancing price and STEM price still elevated despite regression from record highs
- Outages from multiple major gas producers impacted the Q1 WA gas market dynamics.

3 AEMO Project Updates

3.1 WA DER Roadmap update

Tom Butler (AEMO) presented an update on the WA DER program, providing a high-level update on Project Symphony, DER Participation, Technology integration and DER Register. Noting the over status is Amber due to some delays. The next WA DER market participation forum will be held on 14 June 2023.

3.2 WEM Reform Program update

Andrew Smith (AEMO) provided an update on WEM Reform Program noting the program remains on track for new market commencement on 1 October 2023. The RCM NAQ framework was implemented on schedule and market trials have now commenced. Following board approval of revised budget the status has improved but remains amber to reflect the tight schedule and level of risk. The next WEM Reform Implementation Group will be held on 11 May 2023.



4 Allowable Revenue and Forecast Capital Expenditure (AR6) in-period submission update

Martin Maticka (AEMO) provided an overview of AEMO's AR6 in-period submission proposal noting, AEMO's approach to governance, forecasting, labour and contingency costs for WEM Reform and provided an opportunity for stakeholder questions.
