This Notice of Termination will be subject to cessation of Rule Participant registration status according to clause 2.32.7 of the Wholesale Electricity Market Rules.
- b) Breach of any of the conditions in: 1(b), 1(c) or 1(d) listed above.
- c) Cessation of registration for GST by either AEMO or THE MARKET PARTICIPANT.
