

NOTICE OF FURTHER CONSULTATION PERIOD FOR PROCEDURE CHANGE PROPOSAL PC_2012_10

Following the closure of the public consultation period for the Procedure Change Proposal: Amendments to Market Procedure for IMS Interface (PC_2012_10) the IMO and System Management identified a number of issues with the proposed amended Market Procedure. To address these issues the IMO, in consultation with System Management, has proposed some additional amendments to the Market Procedure, further details of which are provided below.

The IMO acknowledges that section 2.10 of the Market Rules does not specifically contemplate a second consultation period for a Procedure Change Proposal. However, the IMO considers it appropriate to undertake a further informal consultation process to allow interested parties, if they consider it appropriate, to make submissions on the revised Market Procedure presented as Appendix 1 to this notice.

Any informal submissions must be delivered to the IMO (<u>market.development@imowa.com.au</u>) by **5:00pm on Monday**, **18 February 2013**.

Revised Procedure

The IMO has proposed the following further amendments to the Market Procedure:

- removal of proposed changes to the size of some data elements;
- removal of proposed changes to the validation requirements for some data elements;
- updates to section 4.4, to clarify the requirements for plain text acknowledgement files and to specify the use of XML format acknowledgement files for certain interfaces; and
- changes to specific interfaces as outlined in the following table.

MF_BA_SCHEDULE	Remove proposed changes to the descriptions of START_DATE and END_DATE
MF_DELIVERY_POINTS	Include "D" (Deregistered) as an allowed value for FACILITY_STATUS.
LOAD_FORECAST_BALANCI NG	Include new data element ZONE_NAME with a required value of "WEMS".
NON_SCHEDULED_GENER ATION_FORECAST	Specify that the interface must be operational by 1 December 2013.
RELEVANT_DISPATCH_QUA NTITY	Update transfer timing to remove the requirement to provide data through this interface after every Trading

SM_SCADA_TEMPERATURE _DATA	Remove the proposed change to the description of READING_TIME.
LOADWATCH_LOAD_FORE CAST	Specify that the interface must be operational by 1 December 2013.
LOADWATCH_TEMP_FORE CAST	Specify that the interface must be operational by 1 December 2013.
ST_PASA	Specify that the interface must be operational by 1 December 2013.
MT_PASA	Specify that the interface must be operational by 1 December 2013.
