For 2018 Quarter 2 this information has previously been published by AEMO. In accordance with Clause 11.3 of the Auction Rules, AEMO has subsequently reconciled the auction expense fees recovered for 2016/17 against costs incurred and determined that there was an over recovery. AEMO has therefore adjusted the auction expense fees for 2017/18 to return the difference found in 2016/17. The original and revised auction expense fees for 2018 Quarter 2 are presented below.
