

Unit Category Data – July to September (Q3) 2020 – Revised v4

Clauses 4.5, 5.3 and 15.1 of the Auction Rules require AEMO to advise Auction Participants of the following information concerning the auction of the inter-regional settlement residue units for a given quarter:

• Proportions.

• The dates on which auctions will be held.

• Maximum number of units.

• Auction allocation and cancellation fees.

For 2020 Quarter 3 this information has previously been published by AEMO. In accordance with Clause 15.3 of the Auction Rules, AEMO has subsequently reconciled the auction expense fees recovered for 2019/20 against costs incurred and determined that there was an over recovery. AEMO has therefore adjusted the auction expense fees for 2019/20 to return the difference in 2020/21. The revised Allocation and Cancellation fees for 2020 Quarter 3 are presented below.
