

## Unit Category Data - October to December (Q4) 2022 - Revised

Clauses 4.5, 5.3 and 15.1 of the Auction Rules require AEMO to advise Auction Participants of the following information concerning the auction of the inter-regional settlement residue units for a given quarter:

• Proportions.

• The dates on which auctions will be held.

• Maximum number of units.

• Auction allocation and cancellation fees.

For 2022 Quarter 4 this information has previously been published by AEMOIn accordance with Clause 15.3 of the Auction Rules, AEMO has subsequently determined that there will be an under recovery. AEMO has therefore adjusted the auction expense fees for 2022/23. The revised Allocation and Cancellation fees for 2022 Quarter 4 are presented below.
