

## Unit Category Data – April to June (Q2) 2023 - Revised

Clauses 4.5, 5.3 and 15.1 of the Auction Rules require AEMO to advise Auction Participants of the following information concerning the auction of the inter-regional settlement residue units for a given quarter:

- Proportions.
- Maximum number of units.
- The dates on which auctions will be held.
- Auction allocation and cancellation fees.

For 2023 Quarter 2 this information has previously been published by AEMO. In accordance with Clause 15.3 of the Auction Rules, AEMO has subsequently determined that there will be an under recovery. AEMO has therefore adjusted the auction expense fees for 2022/23. The revised Allocation and Cancellation fees for 2023 Quarter 2 are presented below.
