

Unit Category Data – July to September (Q3) 2023 - Revised

Clauses 4.5, 5.3 and 15.1 of the Auction Rules require AEMO to advise Auction Participants of the following information concerning the auction of the inter-regional settlement residue units for a given quarter:

• Proportions.

• The dates on which auctions will be held.

• Maximum number of units.

• Auction expense fee (allocation/cancellation) per unit.

In accordance with Clause 15.3 of the Auction Rules, AEMO has subsequently reconciled the auction expense fees recovered for 2022/23 against costs incurred and determined that there was an under recovery. AEMO has therefore adjusted the auction expense fees to recover the difference in 2023/24. The revised auction expense fees for 2023 Quarter 3 are presented below.
