

## Unit Category Data – October to December (Q4) 2025 - Revised

Clauses 4.5, 5.3 and 15.1 of the Auction Rules require AEMO to advise Auction Participants of the following information concerning the auction of the inter-regional settlement residue units for a given quarter:

- Proportions.
- Maximum number of units.

- The dates on which auctions will be held.
- Auction expense fee (allocation/cancellation) per unit.

In accordance with Clause 15.3 of the Auction Rules, AEMO has revised the forward expenditure and adjusted the auction expense fees accordingly. The revised auction expense fees for 2025 Quarter 4 are presented below.
