In accordance with Clause 11.3 of the Auction Rules, AEMO has subsequently reconciled the auction expense fees recovered for 2014/15 against costs incurred and determined that there was an over recovery. AEMO has therefore adjusted the auction expense fees for 2015/16 to return the difference in 2014/15. The original and revised auction expense fees for 2015 Quarter 4 are presented below.
