

Unit Category Data – October to December (Q4) 2019 – Revised v2

Clauses 4.5, 5.3 and 11.1 of the Auction Rules require AEMO to advise Auction Participants of the following information concerning the auction of the inter-regional settlement residue units for a given quarter:

• Proportions.

• The dates on which auctions will be held.

• Maximum number of units.

• Auction expense fees.

For 2019 Quarter 4 this information has previously been published by AEMO. In accordance with Clause 11.3 of the Auction Rules, AEMO has subsequently reconciled the auction expense fees recovered for 2018/19 against costs incurred and determined that there was an over recovery.
