

Unit Category Data – April to June (Q2) 2021 – Revised v2

Clauses 4.5, 5.3 and 11.1 of the Auction Rules require AEMO to advise Auction Participants of the following information concerning the auction of the inter-regional settlement residue units for a given quarter:

• Proportions.

• The dates on which auctions will be held.

Maximum number of units.

Auction expense fees.

For 2021 Quarter 2 this information has previously been published by AEMO. AEMO has subsequently reviewed the auction expense fees previously set for 2020/21 and determined that there was an over recovery. AEMO has therefore adjusted the auction expense fees for 2020/21. The original and revised auction expense fees for 2021 Quarter 2 are presented below.
