

Unit Category Data – January to March (Q1) 2022 - Revised version 2

Clauses 4.5, 5.3 and 15.1 of the Auction Rules require AEMO to advise Auction Participants of the following information concerning the auction of the inter-regional settlement residue units for a given quarter:

- Proportions.
- Maximum number of units.

- The dates on which auctions will be held.
- Auction allocation and cancellation fees.

For 2022 Quarter 1 this information has previously been published by AEMO. In accordance with the Auction Rules change to include Secondary Trading, AEMO has subsequently adjusted the auction (Allocation) fees to include Cancellation Fees. The Allocation and Cancellation fees for 2022 Quarter 1 are presented below.
