For 2018 Quarter 3 this information has previously been published by AEMO. In accordance with Clause 11.3 of the Auction Rules, AEMO has subsequently reconciled the auction expense fees recovered for 2017/18 against costs incurred and determined that there was an under recovery. AEMO has therefore adjusted the auction expense fees for 2018/19 to return the difference found in 2017/18. The original and revised auction expense fees for 2018 Quarter 3 are presented below.
