For 2021 Quarter 3 this information has previously been published by AEMO. AEMO has subsequently reviewed the auction expense fees previously set for 2021/22 and determined that there was an over recovery. AEMO has therefore adjusted the auction expense fees for 2021/22. The original and revised auction expense fees for 2021 Quarter 3 are presented below.
