1. Introduction

Section 3.18 of the National Electricity Rules (NER) authorises AEMO to conduct Settlement Residue Auctions. Clause 3.18.5 requires AEMO to establish a Settlement Residue Committee (SRC). One function of the SRC is to report on the auctions conducted by AEMO (clause 3.18.5(b)(3)). The purpose of this document is to report on the auctions conducted by AEMO on 15 December 2020 and the distribution of residues for 2020 Quarter 4.

Note that all prices quoted in this report exclude GST.

2. Participation

To be eligible as an Auction Participant, Market Customers, Generators and Traders must enter into an Auction Participation Agreement (APA) with AEMO.

For this auction, 51 APA holders were able to bid at the Auctions and 20 participants lodged bids.¹

3. Auction Conducted

AEMO conducted a single auction covering the twelve quarters on 15 December 2020 as follows.

4. Auction Results

4.1 Settlement Residue Auction Units

All AEMO primary allocation units offered to date have been sold.

¹ This compares with 47 APA holders and 19 participants who lodged bids for the last auction (2020 Quarter 3), and 45 APA holders and 18 participants who lodged bids at the 2020 Quarter 2 auction.

Of all 2020 Quarter 4 cancellation units offered, 4.8% were sold.

Figure 1 NSWQLD Clearing Prices




Figure 2 QLDNSW Clearing Prices




Figure 3 SAVIC Clearing Prices




Figure 4 VICSA Clearing Prices




Figure 5 NSWVIC Clearing Prices





Figure 6 VICNSW Clearing Price



5. Inter-Regional Settlement Residue

The table below lists the residue payments for 2020 Quarter 4.

In summary for the quarter:

- approximately \$59.04 million of residues was distributed to unit holders
- auction proceeds were approximately \$31.82 million for allocation units and \$0.21 million for cancellation units
- total negative residues were approximately \$5.39 million
