

Summary of Certified Reserve Capacity Assigned by Facility for the 2024 Reserve Capacity Cycle

For the Capacity Year from 1 October 2026 to 1 October 2027.

The Australian Energy Market Operator (AEMO) has assigned **6228.263 MW** of Certified Reserve Capacity (CRC) to Facilities in respect of the 2024 Reserve Capacity Cycle.

The assignment of CRC **does not** automatically entitle a Market Participant to receive Capacity Credits or associated payments. Capacity Credits are assigned after Market Participants have completed Bilateral Trade declarations, have lodged any required Reserve Capacity Security (for new capacity and upgrades, or Facilities which have undertaken significant maintenance), and the Network Access Quantity (NAQ) model has been run. Capacity Credits are capped at the NAQ.

	4.1.18A	AEMO publishes the Reserve Capacity Prices (fixed, transitional, and peak RCP and aggregated quantity of MW of Capacity Credits.	
1 October 2024	4.1.21	Market Participants may apply for a recalculation of the amount of Reserve Capacity Security or DSP Reserve Capacity Security (applications may only be made after this date).	
30 October 2024	4.1.21A	Market Participants must notify AEMO of the number of Capacity Credits that are to be associated with each component of a Facility, where applicable.	
6 November 2024	4.1.22	AEMO sets and publishes the number of Capacity Credits associated with each component of a Facility.
