Pre-production refresh	Wednesday 22 February 2017	Refresh of the pre-production system with data refreshed from the production system.  An outage of up to five days can occur to the pre-production environment during this period. Participant access is not restricted, however, AEMO do not guarantee the pre-production data content or system availability.
Pre-production implementation – release	Thursday 23 February 2017	AEMO implements the Release to pre- production for final system/integration testing.
Participant Testing	Monday 27 February to Friday 10 March 2017	Pre-production testing period for participants.
Production implementation – release	Wednesday 22 March 2017	AEMO implements the Release to production.

### (P346) Contingency Gas Confirmation

#### Summary

The current manual Contingency Gas process represents a risk to participants and AEMO due to manual processing errors in data input, validation and scheduling. The Contingency Gas Confirmation project reduces risk for participants and AEMO by replacing these manual processes with streamlined automated processes.

#### Detail

AEMO is making the following changes to STTM market systems:

AEMO will develop:

- A SWEX Contingency Gas Confirmation input screen for participants to validate confirmations as they are submitted.
- Two new MIS reports for participants.
- AEMO has enhanced the STTM market system to automate the Contingency Gas scheduling process.

**Note:** There is no change to SWEXIE as AEMO cannot justify the cost to implement this change. In addition, participants using SWEXIE indicate it is not required.
