1 Introduction

1.1 Purpose

This guideline has been produced to map the Postcode to Withdrawal Zone in the Queensland Gas Retail Market to ensure compliance with the Retail Market Procedures (Queensland) 6.2.2 (c).

This procedure requires that *"Before 1 August annually, each must use reasonable endeavours to review the mapping of all postcodes to withdrawal zone in their distribution region, and provide AEMO with an updated list of postcode to withdrawal zone mappings"*.

Annually AEMO will contact the distribution companies in Queensland and request an update. An updated version of the Postcode to Withdrawal Zone for Queensland will be published by AEMO.

1.2 Audience

This guideline is aimed at participants in the Queensland Gas Retail Market.

Heating Value Zone (HVZ)	In relation to a supply point, the heating value zone (if any) which is determined by AEMO as the heating Value Zone for that supply point
Withdrawal Zone (WZ)	A grouping of distribution areas, not including those covered under an excluded distribution authority, as defined by AEMO for the purpose of balancing or the calculation of STTM distribution (as the case may be). Also see clause 1.3A of the Retail Procedures (Queensland).
MIRN	<p>In relation to a supply point at any time, the Metering Installation Registration Number (MIRN) for that supply point as recorded at that time:</p> <ul style="list-style-type: none"> (a) where the supply point is a distribution supply point, in the MIRN database of the Distributor in whose distribution area that supply point is located; and (b) where the supply point is a transmission supply point, in the AEMO meter register, <p>Please note that acronyms MIRN (Metering Installation Registration Number) and NMI (National Meter Identifier) are used in this document interchangeably.</p> <p>A MIRN is a sub-class of National Metering Identifier (NMI).</p>

2. Postcode areas may be split into two "portions" along geographic boundaries to maintain consistency with gas flows.
3. The defined boundaries are based on reasonable endeavours to match postcode areas to the usual gas flows.
