2. RESOLVED ISSUES

•	GISP-943	Updates to the GBB (WA) homepage topology map to address registration changes.	The GBB (WA) map will display appropriate changes to facility registration data at the appropriate times.
•	GISP-941	The GBB (WA) map displays 'Total Production' and 'Total Consumption' instead of 'Total Receipt' and 'Total Delivery respectively.	The current terms used on the GBB (WA) map incorrectly represent the data it currently displays. This is because the flow of gas between pipeline networks is accounted for within the gas flows, but cannot be attributed to production or consumption. The GBB (WA) map will correctly re-label the information being presented as 'Total Receipt' and 'Total Delivery' as per GSI Rule 91(2)b. <i>Please refer to Section 3 for screenshots.</i>
•	GISP-942	The GBB (WA) storage capacity graphic on the homepage incorrectly displays the Mondarra storage information.	The GBB (WA) storage capacity graphic is displaying Receipts as gas which is received by the storage facility and Delivery as the gas delivered into the pipeline. This graphic has been updated to correctly display Receipts as gas delivered into the pipeline and Delivery as gas which is received by the storage facility. <i>Please refer to Section 3 for screenshots.</i>


