



# 3 Monthly Trucked Gas Report

The Monthly Trucked Gas Report was introduced in the previous GBB 1.18 release as one of the changes required to accommodate GRC\_2022\_01¹. The report has been amended to include the unit (TJ) in the *Quantity* header, and to display data to 3 decimal places to reflect submission data (Figure 2).

# 4 Emergency Management Facility (EMF)

When the EMF is activated following an EMF Direction from the WA Coordinator of Energy, an indicator is displayed on the GBB (WA) homepage (Figure 3). Previously the EMF Direction PDF could only be download by users who are logged in to the system, a fix have been introduced to allow all visitors to the GBB (WA) homepage to download the EMF Direction (Figure 4).

• GISP-1252	MOSMI alert for AEMO to be notified if a Facility that has never made a Monthly Trucked Gas submission has made a submission for the current period.	N/A
• GISP-1255	When a Monthly Trucked Gas report is re-generated for a historic date, it will include additional Facilities that have made more recent submissions.	Fixed to ensure only relevant Facilities are displayed for each historic Monthly Trucked Gas report.
