# 1 INTRODUCTION

# 2 WHAT'S NEW IN WEMS 3.10.1

#### 2.1 RC\_2013\_23 - PRUDENTIAL REQUIREMENTS

WEMS 3.10.1 includes improvements to Prudential Risk Monitoring functionality arising from RC\_2013\_23.

#### **Prudential Security Table:**

A number of changes have been made to the prudential security table to provide a clearer picture of a Market Participant's exposure. Firstly, the sign of all dollar amounts has been standardised such that a positive number represents monies to be paid to the IMO and a negative number represents monies to be paid to the Market Participant.

In addition, this WEMS release introduces a number of changes to the data represented in this table with several fields being removed, some added and others being modified. Below is a summary of these changes:

#### **Fields Removed:**

- Stem Daily Trade Imbalance
- Non-Stem Daily Imbalance
- Stem Trade Imbalance
- Non-Stem Trade Imbalance
- Actual Net Exposure
- Stem Forecast Exposure
- Non-Stem Forecast Exposure
- Credit Limit

#### Fields Added:

- STEM Historical Daily: Represents the daily average of the most recent STEM Settlement Invoice.
- *NSTEM Historical Daily:* Represents the daily average of the most recent Non-STEM Settlement Invoice.
- Calculated At: This represents the time which the Outstanding Amount was calculated.

Fields Modified: (additions represented by <u>underline</u> and deletions by strikethrough):

• *Invoice Not Paid:* Sum of unpaid STEM invoices, unpaid Non-STEM invoices and <u>Prepayments received by the calculation time.</u>



- Outstanding Amount: The sum of Actual Net Exposure, STEM Forecast Exposure and Non-STEM Forecast Exposure. Invoice Not Paid plus <u>Accrued exposure (STEM and</u> NSTEM) up to the Calculated At date based on the Historical Daily values.
- Trading Margin: Outstanding Amount (exposure) + Trading Limit (covered exposure).
  Trading Limit less Outstanding Amount.



# **Prudential Security Chart:**

The Prudential Security Chart has been simplified to only display the Credit Support, Trading Limit and Outstanding Amount. Actual Net Exposure and Credit Limit have been removed from the chart.

In addition to this, the chart now displays forecast data up until the end of the current NSTEM settlement cycle.



# **MPI Registration:**

The prudential section on the Participant Information page has been removed as the IMO will be maintaining this information outside the Registration system. Market Participants will now only have to ensure the accuracy of information contained within the General Information and Financial Information sections of the Participant Information section.
