## **CONSULTATION ON CHANGES TO THE TRANSPORTATION SERVICE POINT REGISTER (TSPR)**

The following notice is sent with respect to 3.2.4 of the Capacity Transfer and Auction Procedures. AEMO is performing an *expedited* consultation on proposed zones, pipeline segments and backhaul auction services. Relevant *facility operators* and other interested stakeholders are invited to submit written comments on this proposal to AEMO by close of business Monday 23 August 2021.

AEMO notified stakeholders of these changes through the Gas Wholesale Consultative Forum on 21 June 2021.

### **1. OVERVIEW OF CHANGES**

AEMO proposes the following changes to the TSPR:

- Jemena have informed AEMO that Orbost is a forward haul delivery point
  - Change the Eastern Gas Pipeline (EGP) to include new Delivery Zone DZ-08
  - Add Orbost as a Forward Haul Delivery Point to this new Delivery Zone DZ-08 (refer schematic diagram in Section 5 below)
- APA have requested a name change on the Moomba Sydney Pipeline (MSP) to better describe the delivery point.
  - Rename the delivery point 'SWQP Exit' to 'MCF Exit'.
- Transitional Firm Rights have ended and AEMO will be removing the reference to these rights in the Facility Description to be:
  - Eastern Gas Pipeline ~~Transitional Firm Rights exist on this facility~~
  - Moomba to Adelaide Pipeline System ~~Transitional Firm Rights exist on this facility~~
  - VicHub ~~Transitional Firm Rights exist on this facility~~
- Update service point on the Port Campbell to Adelaide Pipeline
  - Rename the receipt point 'Minerva – PCA' to 'Athena – PCA'
- Update service points on the Port Campbell to Adelaide Pipeline
  - Rename the receipt point 'Minerva – PCI' to 'Athena – PCI'
  - Rename the backhaul delivery point 'Minerva – PCI' to 'Athena – PCI'
  - Rename the delivery point 'Minerva – PCI' to 'Athena – PCI'
  - Update the description for PCI-RZ-01 to be Athena Receipt
  - Update the description for PCI-DZ-01 to be Athena Delivery
  - Update the To Location for PCI-BS-01 to be Langley – PCI, Athena – PCI
  - Update the first dot point in the forward haul segments to be
    - Forward haul segments from Athena receipt zone to Athena, DWGM and Mortlake delivery zones (FS-01,FS-02, FS-03).

## 3. MAGNITUDE OF THE CHANGES

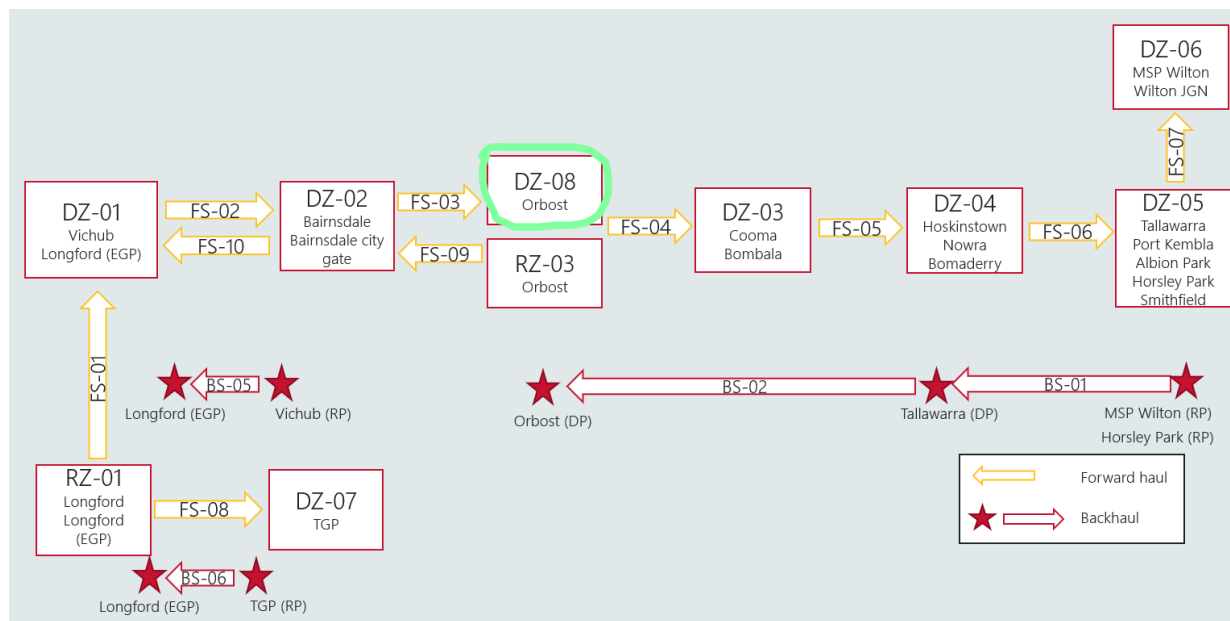
The proposed amendments are non-material changes to current market operations. The changes require arrangement by AEMO for IT database updates.

## 4. PROPOSED TIMELINES

The EGP will be changed when an agreed date is arranged between AEMO and Jemena. The change requires some minor IT database amendments. The MSP will also be changed when an agreed date is arranged between AEMO and APA. For this reason, a proposed effective date will be notified later following the closing date for submissions.
