EXECUTIVE SUMMARY

The publication of this Paper completes the process (Process) conducted by AEMO to consider the proposed minor amendment (Proposal) to the effective date from 14 March 2022 to 1 May 2022 (Effective Date Amendment) of the changes (Changes) to procedures (Procedures) in respect of:

- MSATS Standing Data Review (MSDR) Phase 1, which incorporates Metering Coordinator Planned Interruption (MCPI).
- Parts of the Metering ICF Package 2020.

AEMO completed the full consultations on the Changes in 2020 in accordance with rule 8.9 of the National Electricity Rules (NER) (Full 2020 Consultations).

AEMO received four submissions in response to the Minor Amendment Proposal Paper (Proposal Paper). These submissions supported the Proposal and provided suggested future activities.

AEMO's final determination is to amend the Procedures in the form published with this Final Report. The effective date of these amendments is 1 May 2022.

1. PROCESS

AEMO has undertaken the Process in accordance with NER 7.16.7(e).

The publication of this Final Report marks the completion of the Process. The Final Report presents AEMO responses to the feedback received.

BACKGROUND

On 18 December 2020, AEMO issued the "Notice for the proposed delay of MSDR/MCPI", from NEM.Retailprocedureconsultations@aemo.com.au (Initial Notice).

The Initial Notice informed all registered participants that AEMO proposes the short delay of seven weeks from 14 March 2022 to 1 May 2022 in respect of the implementation of the Changes (Implementation Delay). The stakeholder feedback to the Initial Notice was in favour of the Implementation Delay.

The Implementation Delay is to mitigate risks identified between the timing of these initiatives and Global Settlement, which commences on 1 May 2022. The Initial Notice requested any preliminary feedback on the Implementation Delay by 11 January 2021.

Further, on 18 December 2020, AEMO presented and discussed the proposed Implementation Delay at the Electricity Retail Consultative Forum (ERCF) – including in the context of the plans to consult with industry on the updated Regulatory Implementation Roadmap (version 4) in early 2021, with the involvement and support of the Australian Energy Regulator (AER) and Australian Energy Market Commission (AEMC).

Subsequently, on 1 February 2021, AEMO confirmed in a letter to the AER and AEMC that the Implementation Delay should have no flow on effects in respect of the compliance of market participants, with the consequence that AEMC staff did not express any objections from its policy perspective.

Finally, on 8 February 2021, AEMO received a letter from the AER which noted the Implementation Delay, in the further context of the positive feedback in four submissions in respect of the Implementation Delay, as well as the absence of negative feedback.

2.1 NER requirements

AEMO is responsible for the establishment and maintenance of metering procedures specified in NER Chapter 7 except for procedures established and maintained under NER 7.17.

The procedures authorised by AEMO under NER Chapter 7 must be established and maintained by AEMO in accordance with the NER, including NER 7.16.1 and 7.16.7(e).
