Executive summary

The publication of this final report (**Final Report**) concludes the expedited rules consultation procedure conducted by AEMO (**Consultation**) on the proposal (**Proposal**) to amalgamate the MSATS CATS and WIGS Procedures effective 15 November 2024. The Proposal is to amend the following documents (**Documents**) into a single document:

- MSATS Procedures: CATS Procedure.
- MSATS Procedures: WIGS Procedure.

In addition, AEMO proposed to update the following documents impacted by the amalgamation of the MSATS CATS and WIGS Procedures:

- Retail Electricity Market Procedures Glossary and Framework.
- MSATS Procedures MDM Procedure
- Standing Data for MSATS
- MSATS National Metering Identifier Procedure
- NMI Standing Data Schedule

AEMO thanks all stakeholders for their responses during the Consultation, which was undertaken in accordance with NER 8.9.1, following the procedure in NER 8.9.3.

The Amendments have been broadly supported by stakeholders in the Electricity Retail Change Forum (ERCF) and in this consultation.

AEMO's final determination on the Proposal is to amend the Documents in the form published with this Final Report, with an effective date of 15 November 2024.

2. Background

2.1. Context for this consultation

AEMO proposes to amalgamate the MSATS CATS and WIGS Procedures documents into a single document. The amalgamation will achieve the following benefits:

- Provide one source document for participants for the MSATS CATS and WIGS Procedures.
- Efficiency: avoid unnecessary duplicate work by AEMO when updating the two procedure documents with the same changes.
- Consistency: improve AEMO's ability to maintain consistency across both CATS and WIGS
 content by updating one document instead of two.
- Better version control: avoid the need to include the WIGS Procedure document in consultations when no changes have impacted WIGS just to continue to align the version numbers for both CATS and WIGS procedures.

AEMO considers the amalgamation to be a Non-Material Proposal. A Non-Material Proposal is a Proposal that, if implemented, will be unlikely to have a significant effect in the NEM on the activities of the Registered Participants to which the proposal relates. There will be no change to the rights and obligations of participants arising from the amalgamation, rather the two procedure documents are proposed to be amalgamated into one document to provide one source document.

2.2. NER requirements

NER 7.16.1 requires AEMO to maintain the procedures specified in NER Chapter 7 (except for procedures under NER 7.17) in accordance with the Rules consultation procedures.

2.3. The national electricity objective

Within the specific requirements of the NER applicable to the Proposal, AEMO seeks to make a determination that is consistent with the national electricity objective (**NEO**) and, where considering options, to select the one best aligned with the NEO.

The NEO is expressed in section 7 of the National Electricity Law as:

to promote efficient investment in, and efficient operation and use of, electricity services for the long term interests of consumers of electricity with respect to:

- (a) price, quality, safety, reliability and security of supply of electricity; and
- (b) the reliability, safety and security of the national electricity system; and
- (c) the achievement of targets set by a participating jurisdiction—
 - (i) for reducing Australia's greenhouse gas emissions; or
 - (ii) that are likely to contribute to reducing Australia's greenhouse gas emissions.

4. Discussion of material issues

4.1. NMI Classification Codes Listed in Change Requests

4.1.1. Issue summary and submissions

AGL recommended including in the amalgamated "MSATS Procedures: Principles and Obligations for All Connection Points" document the full list of NMI classification codes at the beginning of each Change Request (CR) section (as per table 4-D in the "MSATS Procedures: Principles and Obligations for All Connection Points" document) and including a YES/NO indication against each NMI classification code to indicate its relevance for that CR section. AGL's reasoning was that the proposed document would require comparing two tables (the NMI Classification Codes and CRs table and Change Request Status Notification Rules table in each CR section) to identify the variances. AGL also recommended listing all applicable NMI classification codes in the table headings in the objection rules and CR notifications rules sections.

4.1.2. AFMO's assessment

AEMO developed the tables at the beginning of the CR sections for "NMI Classification Codes and CRs" and aimed to keep them concise and simple by only including the NMI classification codes applicable to the CRs involved. This has also been clarified in the last point of each "Conditions Precedent" section before each table. The headings of the tables in the sections of the objection rules and notification rules align with those CR specific NMI classification codes tables. AEMO believes this approach is more precise, simpler, and efficient.

4.1.3. AEMO's conclusion

AEMO concludes the tables at the beginning of the CR sections for "NMI Classification Codes and CRs" in the amalgamated "MSATS Procedures: Principles and Obligations for All Connection Points" document will be kept concise and simple by only including the NMI classification codes applicable to the CRs involved. This has also been clarified in the last point of each "Conditions Precedent" section before the table. The headings of the tables in the sections of the objection rules and notification rules will remain aligned with those CR specific NMI classification codes tables.

4.2. Version Number for the Amalgamated Procedure

4.2.1. Issue summary and submissions

In the draft determination stage of the consultation, AEMO asked stakeholders if they agreed with the proposed version number of v6.0 for the amalgamated "MSATS Procedures: Principles and Obligations for All Connection Points" document or if it should be given the version number v1.0.

- AGL responded that either option is understandable, but a higher version number makes it clear that there are historical versions of the document.
- Red Energy and Lumo Energy agreed with AEMO's proposal to apply a version number of 6.0 to the amalgamated document.

4.2.2. AEMO's assessment

AEMO assesses a higher version number as 6.0 for the amalgamated "MSATS Procedures: Principles and Obligations for All Connection Points" document is preferred to keep track of the version history and the changes of the document.

4.2.3. AEMO's conclusion

AEMO concludes proposed version 6.0 will be retained for the amalgamated "MSATS Procedures: Principles and Obligations for All Connection Points" document.

- MSATS Procedures MDM Procedure v4.7
- Standing Data for MSATS v5.9
- MSATS National Metering Identifier Procedure v7.3
- NMI Standing Data Schedule v1.2
