This notice informs all Rule Participants and interested parties that AEMO has published a Procedure Change Proposal in respect of the WEM Procedure: RCM Constraint Formulation (**Procedure**). AEMO invites submissions on the Procedure Change Proposal.

This consultation is being conducted in accordance with the Procedure Change Process set out in section 2.10 of the Wholesale Electricity Market Rules (**WEM Rules**).

Matters under consultation

AEMO has initiated this Procedure Change Proposal to amend the Procedure to reflect amendments arising from the Wholesale Electricity Market Amendment (Reserve Capacity Reform) Rules 2023, gazetted on 13 December 2023.

These amendments include the removal of all references and requirements associated with "Preliminary RCM Constraint Equations".

AEMO is seeking comment and feedback on:

 whether the proposed changes to the Procedure effectively implement AEMO's intended outcomes and give effect to the WEM Rules.

Invitation to make submissions

AEMO invites submissions on this Procedure Change Proposal, including any alternative options or drafting you consider may improve the proposed WEM Procedure or better meet the Wholesale Market Objectives specified in section 122(2) of the *Electricity Industry Act* 2004 (and clause 1.2.1 of the WEM Rules).

Please identify any parts of your submission that you wish to remain confidential and explain why. AEMO may still publish that information if it does not consider it to be confidential in accordance with the WEM Rules, but will consult with you before doing so.

Meetings

Before the closing date for submissions, you may request a meeting with AEMO to discuss the issues and proposed changes raised in the Procedure Change Proposal, stating why you consider a meeting is necessary or desirable.

If appropriate, meetings may be held jointly with other stakeholders. Subject to confidentiality restrictions, AEMO will generally make details of matters discussed at a meeting available to other stakeholders and may publish those details.
