# Metering Exemptions Delivery

- AEMO advised that the draft version of r44 B2M schema has been published. In addition, further information will be presented at the ITWG meeting scheduled for 30 November.
- AEMO noted that formal testing for Metering Exemptions will commence on 29 January 2024 through to 1 March 2024. In addition, AEMO noted that Q&A sessions will resume in late January 2024.
- AEMO advised that a draft Go-Live plan for March 2024 is expected to be published on 08 January with a final version expected to be published on 6 February 2024.

#### Integrating Energy Storage Systems into the NEM

- AEMO provided a brief update to the IESS project to date and noted that the overall project status is amber. AEMO noted that interim milestones and progress will continue to be tightly managed against Go-Live criteria.
- AEMO noted that integration testing execution started 3-4 days late, due to environment preparation overrun.
- AEMO noted that tech specs were published on 20 November and the PDSE fact sheets was also published on 14 November.

- AEMO noted contingency planning for both Settlement and BDU commencement scenarios
