

#### **Progress Summary**

Overall project status GREEN.

- EMM DM 5.5 Tech Spec (Settlements) published 31 October.
- EMM DM 5.4 released to Preprod 9 October and Prod 6 November.
- <u>Final Industry Go-live Plan published</u> 18 November.
- <u>Final Industry Readiness Approach</u> for Financial Operations published 15 October

### **FPP November Update**

- Upcoming external milestones remain on track, including the commencement of Non-financial operation (NFO) on 9 December.
- Final Go-live Plan published 18 November with deployment activities and timings for Production:
  - FPP reports will start to be populated from 12 noon market time on 9 December
  - Participants will be advised via email once reports have been activated
- AEMO has submitted a rule change proposal to the AEMC to update the basis of allocating FPP trading amounts to the Residual to apply the post-IESS terms (ACE and ASOE) rather than the old term (AGE).
- AEMO is working with an external advisor on the GST treatment of FPP transactions and is proceeding with an application to the ATO for a Private Binding Ruling regarding the GST treatment of FPPs.
- Recordings and the slides from all sessions are available via the FPP project page.
- Industry readiness survey: participants are encouraged to provide feedback on their interest in partaking in the NFO period, and the extent to which industry participants feel informed and prepared to adopt the changes, prior to full rule commencement. Survey can be access <u>here</u>.

#### Settlements Release (FPP-FO)

- The initial release of the FPP Settlements data model tech spec was published 31 October.
- The final <u>Industry Readiness Approach and Go-live Criteria</u> for commencement of financial operations has been published. Noting draft was published 25 Jan together with readiness approach for NFO.



### FPP (NFO) Industry Test Update

- Industry Test Plan was published 2 September 2024.
- Focus of the Industry test was the cutover to the 5.4 data model and the population of the new tables.
- FPP (NFO) Industry Test commenced 25 October 2024
  - Supported by twice weekly Q&A sessions scheduled for ITWG members.
  - All new reports required for Rule commencement are being populated in Pre-prod.
  - Minor issues were raised during the Industry Test but have been resolved.
- FPP (NFO) Industry Test has now concluded. Further support for the FPP (NFO) release can be obtained via the AEMO Support hub <u>support.hub@aemo.com.au</u> or 1300 236 600 noting that the query is in relation to FPP.





#### ST PASA Procedure Indicative Highlevel Timeline



#### **Flexible Trading Arrangements**

On 15 August 2024, the AEMC published the Final Determination.

#### Key changes from the Draft Rule to the Final Rule are:

- Introduction of a 'NMI Service Provider' role, which establishes and maintains a SSP NMI
- Introduction of Type 8A and Type 8B metering types:
  - Type 8A metering installation can be a secondary settlement point for a large or a primary connection point for a Large CER asset.
  - Type 8B metering installation can be a secondary settlement point for a small customer
- Earlier effective date for Type 9 metering installations

- Focus Group sessions:
  - 23 October 2024 DNSPs:
  - 7 November 2024 Retailers:
  - 20 November 2024 MCs/MPs/MDPs
- 31 May 2026 for Type 9 metering installations
- 1 November 2026 for remainder of the reform






In response to stakeholder feedback about customer safeguards of the installation of a smart meter, the AEMC has delayed the publication of the Final Determination until 28 November 2024.

The AEMC has provided the industry with the following proposed effective dates for the reform:

- 1 December 2025: LMRP, Defect Management, Shared Isolation, Testing/Inspection and Malfunctions
- 1 July 2026: Power Quality Data
- 1 December 2030: Program ends

AEMO have deferred package one consultation, with the draft determination to be published on 18 December 2024







#### PEC-MI – *Indicative* Activity Timeline







### Shortening the Settlement Cycle

- AEMC Final Rule will be published on **12 December**
- AEMO has been collaborating with the AEMC on costing and implementation timeframes







### Appendix A: Competition law meeting protocol



#### **AEMO Competition Law - Meeting Protocol**

AEMO is committed to complying with all applicable laws, including the Competition and Consumer Act 2010 (CCA). In any dealings with AEMO regarding proposed reforms or other initiatives, all participants agree to adhere to the CCA at all times and to comply with this Protocol. Participants must arrange for their representatives to be briefed on competition law risks and obligations.

Participants in AEMO discussions must:

- Ensure that discussions are limited to the matters contemplated by the agenda for the discussion
- Make independent and unilateral decisions about their commercial positions and approach in relation to the matters under discussion with AEMO
- Immediately and clearly raise an objection with AEMO or the Chair of the meeting if a matter is discussed that the participant is concerned may give rise to competition law risks or a breach of this Protocol

Participants in AEMO meetings **must not** discuss or agree on the following topics:

- Which customers they will supply or market to
- The price or other terms at which Participants will supply
- Bids or tenders, including the nature of a bid that a Participant intends to make or whether the Participant will participate in the bid
- Which suppliers Participants will acquire from (or the price or other terms on which they acquire goods or services)
- Refusing to supply a person or company access to any products, services or inputs they require

Under no circumstances must Participants share Competitively Sensitive Information. Competitively Sensitive Information means confidential information relating to a Participant which if disclosed to a competitor could affect its current or future commercial strategies, such as pricing information, customer terms and conditions, supply terms and conditions, sales, marketing or procurement strategies, product development, margins, costs, capacity or production planning.
