3 Program & Release Update

Rowena Leung / Jim Agelopoulos (Slides 7-10)

- AEMO provided a program overview and noted key areas that are receiving management attention.
 These areas are IESS June 2024 with the lead up to the June Go-Live. AEMO noted that mobilisation
 of the 2025/2026 Initiatives (IDAM, IDX, PC) is progressing well with further details outlined in agenda
 item 5.
- In addition, AEMO advised that planning and project initiation has commenced for the post 2024 committed initiatives, these include Unlocking CER benefits through flexible Trading, Metering Services Review, Improving Security Frameworks and Enhancing Reserve Information.
- AEMO advised that the NEM Reform program for 2024 has now been locked in.
- AEMO presented the program level 1 & 2 milestones and noted key call outs as outlined on slide 10 of the slide pack.

Industry Risk Register

David Reynolds (Slides 11-13)

- AEMO provided a status update on the industry risk register as of April 2024 (v4) and noted that the Industry Risks and Issues register has been updated to incorporate feedback from industry and is available on AEMO's website¹. In addition, AEMO advised that the next review of the Industry Risks and Issues register will be at our July 2024 PCF.
- AEMO polled participants on the need for a dedicated session on risk at this point in time. While
 participants noted a deep dive session would be useful, at this point there was limited support for such
 a session.

- AEMO provided an update on upcoming initiatives as part of the NEM Reform Program and are outlined below.
 - Unlocking CER Benefits through Flexible Trading
 - AEMC have issued a Draft Determination
 - Sets Proposed Rule Commencement Date of 2 February 2026.
 - Requests stakeholder submissions on Draft 11 April 2024.
 - Final determination July 2024.
 - AEMO held HLIA/ PIA briefing on April 5th and published the HLIA/ PIA on 10th April.
 - Initial views of impacts provided based on AEMC's Draft Determination
 - Informed Go-Live process with RDC will include updated approach to timing based on participant feedback.
 - RDC session held 3rd May and agreed to the updated timeline proposal of 2 November 2026.
 - AEMC have received feedback from the RDC session.
 - RDC Minutes and updated HLIA will be published on AEMO's website in due course.



- Final decision on timing with AEMC.
- o Accelerated Smart Meter Deployment Rollout (Metering Services Review)
 - AEMC issued Draft Determination 4th April.
 - Requests stakeholder submissions on Draft by 30 May 2024
 - AEMO plans to issue HLIA/ PIA post Draft Determination Date 9 May
 - Briefing session scheduled for 16 May.
 - Invitations have been sent to PCF, Implementation forum, ERCF and B2B WG members.
 - Accelerated smart meter rollout timelines are determined through AEMC fast tracked consultation.
 - HLIA/PIA will provide early impact assessment and indicative implementation timeframes for participant planning in line with NEM Reform process.
 - Participants should make their submissions directly to the AEMC regarding the Draft Determination by 30 May 2024.
 - HLIA/PIA will be updated post AEMC Final Decision (scheduled for July 2024).
 - AEMO are currently progressing the policy draft and will provide a review to members in the next month.
