- AEMC have issued a Draft Determination
 - o Sets Proposed Rule Commencement Date of 2 Feb 2026
 - Stakeholder submissions on Draft due 11 April 2024
 - o Final determination due 11 July 2024
- AEMO held HLIA/ PIA briefing on April 5th and published the HLIA/ PIA on 10th April
 - o Initial views of impacts provided based on AEMC's Draft Determination
 - Informed Go-Live process with RDC will include updated approach to timing based on participant feedback
 - RDC session held 3rd May and agreed to the updated timeline proposal of 2 November 2026.
 - AEMC have received feedback from the RDC session.
 - o RDC Minutes and updated HLIA will be published on AEMO's website in due course.
 - Final decision on timing with AEMC.
