1. Welcome and Previous meeting minutes

Martin Maticka (AEMO) opened the meeting at 10:03 am, welcomed attendees to WAGCF No.19

The minutes from the previous WAGCF (27 October 2021) were endorsed. AEMO to publish the minutes as final on the website (Action Item 1.1).

2. 2022 WA Gas Statement of Opportunities (GSOO) Formal Information Request (FIR) analysis and 2021 WA GSOO survey feedback

Sreeparna Saha (AEMO) presented the preliminary analysis of the data received through the FIR process, as well as the analysis of the responses received from the 2021 WA GSOO.

3. GSI Insights

Madison Pigliardo (AEMO) presented the key observations, trends, and outcomes from Quarter 2 2020 to Quarter 2 2022.

4. GBB LNG trucking rule change update

Laura Koziol (EPWA) provided an update on the Rule change proposal: Publication of Tanker Gas Information on the Gas Bulletin Board (GRC_2022_01) noting: The draft rule change report was published on 22 June 2022 and the draft decision was to accept the rule change proposal as proposed. Submissions on this draft rule change report are close on 20 July 2022 at 5pm. Any submission received will be published on 21 July 2022, then the final rule change report to be published on 17 August 2022. The provisional commencement date is 1 December 2022.

5. Reporting Obligations refresher

Rachel Tandy (AEMO) presented a brief overview on the Gas Bulletin Board (GBB) participant reporting obligations.

Stakeholder question and feedback:

Mike Lauer (Gas Trading) was seeking clarification on whether the capacity outlook that is quoted on the flow page in the GBB is the 7-day outlook or it's the day ahead expression of what is in the capacity outlook for the next day or for that day on, it is not the nameplate capacity.

AEMO will look to bring this topic back to the WAGCF at a future date and clarify some of the terminology used on the GBB landing page which publishes some data and visualizations that show the capability of facilities as well as actual flows in the market. System changes are underway to make this clearer in future.

6. AEMO's Allowable Revenue and Forecast Capital Expenditure (AR6) – GSI Outcomes

Martin Maticka (AEMO) presented a summary on AEMO's AR6 expenditure final determination noting the ERA approved the requested Opex with a minor decrease in Capex.

7. Other Business

Laura Koziol (EPWA) noted the Coordinator for Energy has published the call for nominations for the Gas Advisory Board (GAB). All interested parties considering nominating can do so by visiting the [Gas Advisory Board Page](#). Nominations close at 5 pm (WST) on 3 August 2022.
